> ARTICLES OF ORGANIZATION (General Laws, Chapter 180)

> > ARTICLE I

The exact name of the corporation is: SUNNYSIDE RANCH ESTATES PROPERTY OWNERS ASSOCIATION, INC.

### **ARTICLE II**

The purpose of the corporation is to engage in the following business activities:

The promoting and providing for the continued maintenance, repair and replacement and the appearance of the Sunnyside Ranch Estates subdivision in Southwick Massachusetts encompassing islands, entrance monument, street lights, private roads, open space, sidewalks and other future improvements benefiting all lots including snowplowing, ice removal, sanding and landscaping. To ensure that the roads and sidewalks within the Sunnyside Ranch Estates subdivision remain private at all times.

## **ARTICLE III**

A corporation may have one or more classes of members. If it does, the designation of such classes, the manner of election or appointments, the duration of membership and the qualification and rights, including voting rights, of the members of each class, may be set forth in the by-laws of the corporation or may be set forth below:

#### **ARTICLE IV**

\*\* Other lawful provisions, if any, for the conduct and regulation of the business and affairs of the corporation, for its voluntary dissolution, or for limiting, defining, or regulating the powers of the corporation, or of its directors or members, or of any class of members are as follows:

The corporation may not amend its Articles at any time to provide that the streets and ways within the Sunnyside Ranch Estates subdivision in Southwick, Massachusetts may become public ways, unless 66.67% of the members vote that such ways shall become public ways.

### ARTICLE V

The by-laws of the corporation have been duly adopted and the initial directors, president, treasurer and clerk or other presiding, financial or recording officers, whose names are set out on the following page, have been duly elected.

#### **ARTICLE VI**
